

Established in 1993 by 16 Founders, there are now more than 2,700 Founders, and an endowment of over \$5M






## GRANT HISTORY




- 475 GRANTS AWARDED OVER THE PAST 30+ YEARS

- 2025 GRANTS
  - 93 applications received, totaling over \$1,250,000
  - 18 grants awarded, totaling \$227,323

# 2026 GRANT CYCLE



**Jan. 1 - 31st**

Applications accepted online via Grant Portal (Foundant)

**Late March**

Successful applicants identified, and submitted to the FFW & DCF Board of Trustees for approval

**May**

Grant Awards Ceremony

**February & March**

Applications reviewed by Grants Review Committee. Three rounds of reviews

**Mid-April**

Successful applicants will be notified. All applicants will be able to request reviewer comments.



# GRANT APPLICATION CRITERIA AND GUIDELINES

## Applications must:

- Address the needs of Delaware women and/or girls
- Have proof of the Agency's exempt status under section 501(c)3 of the Internal Revenue Code
- Include a detailed description of the *project budget*, and the organization's budget – see later slide for examples & more info.
- Be received in our Foundant system by Midnight on January 31, 2025.
- All 2025 grant recipients, must be current on their grant mid-year follow up reports before submitting an application for 2026

Note that if your organization has received grants in 2023, 2024 & 2025 from the FFW we ask that you wait a year before submitting an application in 2026.



# GRANT APPLICATIONS TO BE EXCLUDED

If any of the following apply:

- Funding request is for an individual, or potentially could only be used for only 1 person
- Organization does not have 501(c)3 status
- Funding request is for capital
- Funding is for debt reduction
- Project is for an endowment campaign
- Request for funding exceeds \$15,000
- Agency has received a grant for the prior 3 years to this grant.
- Agency received a prior FFW grant and failed to submit a timely final grant evaluation of the project



# RATING CRITERIA

- The Fund for Women focuses its grant-making on programs relating to:  
*Health, wellness and life skills that lead to future economic self-sufficiency for girls and women in Delaware*
- Many programs that could lead to future economic self-sufficiency, include:  
*Arts, sports, mentoring, education, food, financial literacy, clothing, jobs training, etc.*
- Remember our mission: “To empower women and girls to achieve their potential”



## GRANT READERS ARE LOOKING FOR:

- Overall value
- Proposal is clear, organized and complete
- Identified source for participants in the project
- Collaboration/Leveraging (with other entities)
- Innovation/Creativity/Uniqueness
- Number of women/girls impacted
- County/Counties served






# GRANT READERS ARE LOOKING FOR:

- Need and value of program and its services offered
- Clear goals and measurable objectives
- Plan to objectively measure results
- Clear description of project needs and how it will impact the lives of recipients
- Reasonable allocation of resources
- Sound methodologies
- Plan for staffing the project



- WHAT IS THE NEED YOU EXPECT TO FILL WITH THIS PROJECT?
  - Why are you doing this?
  - What need does this project address? You can use data to back up the need.
  - How will the project meet the need?
  - What are the longer term outcomes for women and girls?




# MEASURES OF SUCCESS

- How will you measure success and how will you know if the project has been successful? Be specific about your goals. Include the data that will be collected, major milestones where measurement will be taken and timeline for data collection.
- Describe how the project will be sustainable over the next 5 years.

## EXAMPLES – MEASURES OF SUCCESS


### **Have a goal and measure against that goal**

Multiple measures are helpful. For example -

Temporary housing program – number / of women moving to permanent housing and


Financial literacy – reducing debt / creating a budget / savings increase / credit score increase

Counseling / education – use surveys before & after, quantify emotional goals, use industry metrics





# COLLABORATION




# DIVERSITY, EQUITY AND INCLUSION:

- There is a section towards the end of the application, asking for questions about your organization, and your efforts around DEI
- This information will not impact your chances for an award, the reviewers will not see this information.
- We are hoping that by asking this information, it will prompt your organization to begin these conversations and tracking if you have not already done so.
- It will also give FFW a baseline on where we stand with grantee organizations and help us determine how we can be the most equitable in our granting.



# FINANCIALS



- FINANCIAL STATEMENT
  - Statement of Revenue page of your 990 part VIII for both 2023/2024
  - Accounting records showing the board approved budget and actuals
- CURRENT OPERATING BUDGET
- PROJECT BUDGET
  - Clearly and specifically itemize the costs that will be covered by a Fund for Women Grant –



This is an example. If you have a clear project budget that you are using, that is fine to submit.

Financial Statements are attachments in the grant portal. They must be either a word or excel document in order to be accepted by the Foundant grant portal.





## NEW FOR 2026 – PILOT PROJECT

We recognize that not every organization has professional grant writers. Our goal is to empower your organization to not only improve your FFW grant application, but all grant applications.

**Focus:** Review applications for measures of success and budgets.

**Criteria:** Organization has not had a grant from FFW in the last 6 years AND that they request the review by January 10<sup>th</sup> by submitting your (draft) application into Foundant by that date

**Lynn Evans** – volunteered to assist with these reviews. She is not scoring grants.

I will supply a word document version of the application if you want to submit a draft to the grants email before Foundant goes live on January 1<sup>st</sup>.






